We do not consign any fabric covered items unless fabric is in "like new" condition. We also may offer an outright purchase price for your pieces if we think that it may take longer than 120 days to sell.

### **Terms of Consignment**

Items will be put on the floor as quickly as we can tag them and enter them into inventory.

Fabulous Finds will strive to get the "selling price" you want for your item(s), but reserve the right to reduce the selling price, if necessary, based on demand and experience with like items.

Fabulous Finds cannot be responsible for any damage caused by theft, breakage, fire, flooding, or by any natural occurrence.

### **Terms of Sale:**

Maximum term of consignment is 180 days. We may consider buying your item at this time

After 30 days, we may reduce the price by 10%. After 60 days, we will reduce the original price by another 20%, and so forth by 20% every 30 days.

The consigner will receive 50% of the selling price and Fabulous Finds will receive 50%.

Items that have not sold within 120 days must be picked up within 7 days unless arrangements have been made otherwise. Items that still have not sold after four months are then considered to be the property of Karen Mercer Interiors. We will sell for what we can get or donate it to a charity organization... In the event that a "special sale" is being conducted the consignee's percentage would reflect the sale price as well, regardless of where it falls in the mark-down schedule.

### **Terms of Payment:**

You, as the consignor, will be contacted by email (or telephone if no email is available) when your items sell. Consignor payments for items sold will be available for pick-up on or after the 1<sup>st</sup> Tuesday of each month for the items sold the previous month. Payments are made by Karen Mercer Interiors company check. We ask that you please cash payment checks within 30 days. You, the consignor, state that you are the true owner of the items(s) to be consigned.
